- Read** : Approval of Governor Lampung on Note of Director Pj. Secretary of the Province of Lampung Number: 945.2/353/07/IV/2019 dated 15 April 2019 regarding the Request for Approval of Release of Rights on Land Owned by the Government of Lampung;
- Consider** : a. based on the Decision of Governor Lampung Number: G/387/B.X/HK/2014 regarding the Change of Attachment I and Attachment II Decision of Governor Lampung Number : G/893/B.X/HK/2013 regarding the Determination of Site Plan, Receiver and Land Price of Land Kavling Owned by the Government of Lampung Located in Desa Sabah Balau District Tanjung Bintang Kabupaten Lampung Selatan Which is Directed for Civil Servants, His Brother Mochamad Fadil Hadean, S.E. has been appointed as the receiver of land kavling Block G4 with an area of 400 m²;
- b. that His Brother Mochamad Fadil Hadean, S.E. has fulfilled the obligation of paying the land kavling as follows: intended letter a as large as Rp. 56.920.076,- (Fifty six million nine hundred twenty thousand seven hundred sixty six Rupiah);
- c. that in connection with the meaning of letter a and letter b mentioned above, in the framework of administrative management of regional property, the Release of Rights on Land Owned by the Government of Lampung Which is Located in Desa Sabah Balau District Tanjung Bintang Kabupaten Lampung Selatan to His Brother Mochamad Fadil Hadean, S.E. and its implementation with the Decision of Governor Lampung;
